## Matters Arising:

## a. Dispensary

There is still concern regarding the Dispensary, from both patients and members of the PPG. With this in mind it was agreed that it would be beneficial if the Dispensary Manager was invited to the next meeting. BMcK to contact Alison to arrange this. ### b. Emails

#### c.PPG Presence

## d. Martin Round's report

Martin Round reported on the Group meeting. The turnout was not well attended by PPG groups.

Problems have arisen where ambulances are queuing up to get patients into Lincoln Hospital during the period after lunch, i.e. around 3pm. there can be as many as 18 ambulances waiting to off load patients. 5 Paramedics have been lost, as they have been poached to work as advanced practitioners. 5 Europeans have been recruited. Training to become a Paramedic takes 2 years.

Patient Council wants to target the following:

- i. Health Checks for 40-70 yr olds
- ii. Prescribing on line. It was not made clear what this meant.
- iii. Dementia Diagnosis

## e. Carers quality award scheme

It was reported people not registering as carers saved the health service £1.5bn.

Carers are still not being identified. It was suggested that as some are very young there might be reluctance to be identified because of any repercussions. The message needs to be made aware that it is one of support offered and will not be judgemental on individual situations.

What can the practice do to help?

Some interesting facts.

There are 8.4 million carers in the UK, 7.9m unpaid and 6000 young carers. 25% of carers, care for more than 50 hours per week with 1 in 5 unpaid carers giving up work to care. Nationally the carer's unpaid contribution each year is £132billion.

Dr Roscoe was introduced to the group.
