### **Patient Stats**

- CS shared with the group that LBMC have 3545 patients that have successfully downloaded the NHS APP and are using it.
- We have the highest proportion of patients using the NHS App in our Primary Care Network.

### Home Visit Support Update – KB, AT.

AT raised about patients becoming dependant on visits – he does not feel his
patients are at this level but has often had the thought of this happening – NB
commented that she hoped she would notice if this was the case and AT is
willing to self-manage this situation and communicate with NB should this arise.

#### Dementia Group Support – NB, KB.

- The last session proved to be another success with 30 people attending.
- NB has received feedback from the Speaker of the previous to last session, they commented on how unique this group is and they had not seen another group operate like ours.

#### Foston Neighbours – SB.

- Foston Neighbours have had their AGM since our last meeting They now have two new volunteers. This is welcomed by all at Foston Neighbours.
- SB stated that Foston Neighbours members DBS have been renewed and will let CS have copies of these.

### **Equipment Clinic**

- AT, SB are still available to assist with this project once we get this off the ground.
- JB has had confirmation from Grantham Hospital that they are collecting used equipment and it can be dropped off at the reception desk in the Physio department.
- CS to contact Grantham Hospital, to gauge what equipment they can take back and when we would be able to drop off in order to establish when we can do the drop off clinics here.



### Covid Over 75yrs Invites

- CS informs the group that invites will shortly be going out to those patients who are over 75yrs or are immunosuppressed for their Covid Vaccine.
- These appointments will be held at the Medical Centre and not at the Meres in Grantham as it has done previously.
- The Medical Centre has approx. 1100 patients who are eligible.
- There is a possibility some of these appointments will be offered as a drive through appointment.
