- Use of GP online services stats shared with members. LBMC has a higher percentage of patients that use online services vs the PCN's stats however a lower percentage of patients who book appointments online vs the PCN's percentage. CS asked members how we can encourage more patients to use online services.
- September meeting co-Chair AT away. After further discussion on this it was identified that 3 members would be absent for the next planned PPG meeting.
